# LEE COUNTY: EARLY DAYS IN FORT MYERS

About 1908, Capt. Francis Asbury Hendry, pioneer of the Fort Myers area, wrote a short booklet about that vicinity of south Florida entitled, A HISTORY OF THE EARLY DAYS IN FORT MYERS. F. A. Hendry was the son of James E. Hendry and Lydia Carlton. Mrs. Frances Kay Hendry of North Fort Myers has contributed a copy of that history.

The first historical account we have of Fort Myers is when it was occupied by the United States military on November 4, 1841. It was abandoned March 21, 1842, being occupied but a few months. The place was named then in honor of Lieutenant John H. Harvie, who had died, probably from campaign exposure, about two months before the place was occupied. From 1842 to 1850 there was nothing known of the place and

it appears that it was almost forgotten

It was February 14, 1850, when General Twiggs ordered Major Ridgely to take command of two companies of regular soldiers and proceed to the mouth of the Caloosahatchee, ascend that river and select the most eligible point on its southern bank and establish a military post, clear away the forest, fortify, unfurl Old Glory to the breeze, and to name the place Fort Myers, in honor of Colonel Abraham C. Myers, a distinguished veteran of the Mexican War and at that time the chief quartermaster of the war department of Florida. This officer, when the war between the states in 1861 became inevitable, like the beloved Robert E. Lee, resigned his commission and cast his lot with the destiny of South Carolina, his native State, and was lost sight of.

While we have lost sight of Colonel Myers, a monument has been erected to his memory in the promising little town of Fort Myers, more to be appreciated than marble and stone. The place selected by Major Ridgely, under orders of General Twiggs, was the old site of Fort Harvie, and re-occupied and given a new name, as above stated. Fort Myers, for eight years, was occupied by the military of the United States, and was the scene of much activity on lines of Indian warefare and Indian migra-

tion to the far west.

It was at Fort Myers that Colonel Rector, United States Indian agent, with his delegation of friendly Indians from Arkansas, induced the fearless and indomitable Billy Bowlegs to yield to the scepter of Uncle Sam and turn his back upon his native home, the wilds of Florida, and, with the most of his tribe, migrate to the far west, never to return. That big chief was not scared into the terms offered by Uncle Sam, but he could, savage as he was, read the handwriting upon the wall and interpret correctly. The days of his glory had departed and he gracefully

accepted the inevitable.

Then it was that, about June 1, 1858, Fort Myers was abandoned by the United States forces. In 1859 the Fort was occupied by a civil force, an incorporated company from Virginia, under the management of Major James Evans, whose object was to engage in the culture of fruits and in all kinds of plants common to the tropics and this latitude. Many slaves were brought down from Virginia for the purpose of clearing the lands and improving the, fitting them for that promising industry. The great war between the States caused the abandonment of this project, and the place, in line with its eventful history, was again abandoned and became an uninhabited wilderness, exposed to fire and general devastation.

Four years after, and while the destiny of our country was trembling in the scale of uncertainty, the Federal soldiers took possession of Fort Myers and made it headquarters for all manner of mischief common to warfare. Frequent and destructive raids were made far into the interior and into Confederate lines, causing much distress to the devotees of the Southern cause. Large herds of cattle were rounded up by Federal cavalry and driven to Fort Myers and there slaughtered for use by the garrison

and the blockading squadron of Sanibel Island in San Carlos Bay, and a large number carried on transports to Pine Island, landing about where St. James is now situated.

So annoying was the condition that an unsuccessful attempt was made by Colonel J. C. Munnerlyn's battalion, commanded by Major William Footman, to capture and destroy the place, resulting, however, in its evacuation. Major Footman, after formally demanding a surrender and being denied, raised a terrible racket. A day was spent in cannon and rifle practice, one those bloodless battles, one man killed, a lot of pickets, horses and cattle captured, was the result so far as Major Footman knew, but the most desired result was going on in the front, while Footman was retracing steps, having given up the undertaking as a bad job, the Federals were packing up and hurrying down the river to Punta Rassa, where they placed themselves under cover of their gunboats. The failure to capture the place at that time, under the circumstances connected with it, was as might have been expected.

Two hundred and seventy-five men, poorly armed, with one field piece, attacking five companies of well-armed men, with block houses, breastworks and three field pieces, mounted at commanding points, could not be expected to succeed. While the Confederates could not hurt the enemy much, they gave it a terrible fright, for the next morning the

nest was warm, but the bird had flown.

In mentioning this little unpleasantness, in which Fort Myers played a conspicuous part, mention should be made of the fact that Major Footman completely surprised the garrison when he sent in his flag of truce and politely demanded an unconditional surrender, except that the officers and men be treated as prisoners of war. A picket post was a mile out from the front -- ten men well armed with Enfield rifles. This fact Major Footman ascertained from a reliable source. He was determined to

capture that picket guard.

The night preceding the attack on Fort Myers, the battalion was marching leisurely in a long single file, at a point twelve miles from Fort Myers, along the old military road leading from Fort Myers to Fort Thompson. It was very dark and raining when a halt was made. Major Footman rode down the line and called for Captain Hendry. Being answered, he said: "Captain, I want ten men who can tread on eggs and not break them. Make a detail from your company, dismount them, and place them in command of one of your best lieutenants and have him report to me at once." This order was quickly complied with, when Lieutenant George W. Hendry, in command of ten men of his own choosing, reported to Major Footman.

The Major said to him, in substance: "There is a picket post, one mile from Fort Myers, on a little creek or branch (Billy's Branch). Proceed to that point and capture the picket without firing a gun if possible. I rely upon you. Your plan must be one of your own. Good

night."

Lieutenant Hendry had a hard, difficult and perilous job before him and came as near to accomplishing it as it was possible for him to do. The country was so covered with water and the night so dark, and the pickets without camp fires, that it was absolutely impossible to locate them. He passed within a few yards of the guard on post and did not know it. The picket guard heard the wading in the water and thought it was a herd of cattle passing by. When the day dawned, Lt. Hendry returned to the battalion, meeting it a few miles from Fort Myers. The Major, still determined to capture that picket post, ordered

The Major, still determined to capture that picket post, ordered Lt. William M. Hendry, of Capt. Wall's company, to select from the whole battalion ten men and make a dash upon the picket post. Lt. Hendry then, is now no other than "Uncle Marion" Hendry, present clerk of the Circuit Court. The order was positive to capture without the firing of a gun if

possible. This was a dangerous procedure. Ten men attacking ten men. all well armed, with a position carefully selected. The instructions were, when within a half mile of the point, to dash off at full speed and keep up that speed until they dashed into the picket camp. Well does the writer remember seeing the water fly from under the heels of the chargers in that dash, and the spirit and determined look of these cavalrymen. The writer cannot recall all the names of the men composing that charge. Lt. W. M. Hendry, of Fort Myers; Frank Saxon of Brooks-ville; Gideon Zipperer, Bartow; Benjamin F. Blount, Bartow. Sorry I cannot recall other names. No more daring charge was made during the There was not a gun fired, and every picket was trotting back to the rear in a few minutes, prisoners of war.

Many interesting incidents occurred in that march aid campaign against Fort Myers, which space forbids to mention. So we have reached another occasion for abandonment of this historic place. The fort was abandoned this time hurriedly and in much confusion, leaving three substantial block houses, three dismounted batteries and a long crescentshaped breastworks, extending from where the Royal Palm hotel now stands around to the foot of Hendry street, all of which have been leveled, and there are no signs of it today. The old fort, blessed with so many natural advantages and attractions, so beautifully situated on the beautiful Caloosa river, was destined to be reoccupied at no distant day.

# MANATEE COUNTY: 1880 CENSUS

This census is continued from Issue #9. 1880 Manatee County was divided into 16 precincts: (1) Pine Level, county seat of Manatee; (2) Ft. Green; (3) Ft. Hartsuft; (4) Miacka; (5) Sarasota; (6) Manatee; (7) Palmetto; (8) Oak Hill; (9) Ft. Ogden; (10) Whidden; (11) Boney; (12) Locklear; (13) Williamson; (14) Ft. Thompson; (15) Bassinger; (16) Hickory Bluff. The actual recording of the precinct number on the census is very confusing. Sometimes there are three different precincts on one page - often not subdivided but merely stated on the beginning of the page "includes precinct 10, 12 & 9".

#### WILLIAM HENRY WILLINGHAM 1816-1886

The following sketch has been researched, compiled and contributed by W. H. Willingham's great-great-grandson, Kyle S. VanLandingham, P. O. Box 1779, Ft. Pierce, Fla. 33450.

William Henry Willingham was born in Scotland, April 18, 1816. According to family tradition, at the age of seven years, he was lured aboard a ship and brought to America. The ship landed in Virginia where

William escaped and made his way to south Georgia.

In Ware County, Georgia on July 23, 1838, William Henry Willingham was married to Anna E. Hilliard, daughter of Silas and Abegail (Bulloch) Hilliard. Anna, known as Annie, was born in Bulloch Co., March 19, 1815. William and Annie's marriage was performed by Mr. Benjamin James, Justice of the Peace.

The Willinghams resided in Waresboro, Ware County, until about 1846. William was a farmer and served several enlistments in militia companies during the Second Seminole War. First, in Capt. David Miller's company as a private, June 9 to August 19, 1838; and again for four months, August 20 to December 21, 1838, discharged at Ft. Floyd, Georgia. He later served as 1st Corporal in Capt. Sweat's company of Georgia Mounted Militia, August 19 to November 18, 1840; private under Sweat, Nov. 19, 1840, enlisting at New Orleans, and serving until June 1, 1841. On October 6, 1841, he enlisted once again under Capt. Sweat and served until December 3, 1841, being mustered out at Trader's Hill, Georgia. At the time of service he was described as being 5 feet 9 inches in height, with grey eyes, brown hair and florrid complexion.

About 1846, William and his family moved to Columbia County, Florida where they lived until about 1848, moving to Hillsborough County. William settled about 25 miles east of Tampa in the Alafia settlement, near the present site of Mulberry. He purchased 160 acres of land from Israel Green, Nov. 2, 1852, the land being in Section 9, Township 30 South, Range 22 East. William also acquired in other transactions, 80 acres in Section 10, 80 acres in Section 4, and another 80 acres in Section 9, all the land located in Township 30 South, Range 22 East. On Dec. 1, 1851 William H. Willingham applied for bounty land from the Federal government, based upon his prior military service in the Second Seminole

In 1852 he received 160 acres on Bounty Warrent number 18,549. Upon his removal to Hillsborough County, William Willingham became actively involved in the cattle business. During the Third Seminole War, he served first in Capt. Leroy G. Lesley's company, January 10 to Aug. 20, 1856. Later he served in Capt. John Parker's company, Oct. 8 to Dec. 15,

1856 and later in Capt. F. M. Durrance's company, Dec. 22, 1856 to June 22, 1857; and again from March 11, 1858 to May 9, 1858.

An interesting item appeared in the Florida Peninsular, a Tampa newspaper, May 24, 1856. It concerns an affidavit sworn to by Jesse Alderman before Daniel Sloan, Justice of the Peace. According to the statement, William H. Willingham had told Alderman that a group of men, including N. P. McDonald, John Tyre, and Ell Tyre had formed a club for the purpose of causing mischief in the pioneer communities. They were going to raid homesteads, burn houses, and blame it on the Indians. Willingham had been asked to join the "club" but refused. According to the affidavit, William had been threatened death with a dagger if he told anyone about the plans.

The war ended in 1858 and it was now safe to move into the eastern portion of Hillsborough County. On Oct. 18, 1858, William sold to Milton W. Johnson his stock of cattle for \$3,000. On the same day he sold to Johnson his 400 acres of land in the Alafia section for \$3,000. William

received a stock of cattle and pasture rights on Chloroform Branch at Kissimmee Island, where he resided for about 10 years. Kissimmee Island was a large range located in the Kissimmee River Valley.

Tax statements for Polk County, dated 1862, show that William H. Willingham owned 1550 head of cattle. During the late 1860's William gave his land at Kissimmee Island to his son, William W. "Bill" Willingham, and moved to Fort Meade, where he homesteaded land on the east side of Peace River. The legal description of his 160 acres is the  $E_2^{\frac{1}{2}}$  of the NE $\frac{1}{2}$  of Section 35; and the  $N_2^{\frac{1}{2}}$  of the NW $\frac{1}{4}$  of Section 36, Township 31 South, Range 25 East. Polk County land records show deeds to William H. Willingham from Francis A. Hendry, dated Nov. 3, 1869 for another plot of land; also a deed from the Internal Improvement Fund of Florida to Willingham, dated Nov. 3, 1876.

On the Willingham homestead, William constructed a handsome twostory house. A hand-pegged structure, painted white, it had gingerbread printing on the broad veranda. In the front room was a fireplace, built of limestone blocks William had cut from the banks of Peace River. During the 1880's William owned large orange groves and operated a ferry across

the river at Fort Meade.

the place of burial. William died intestate and Sheriff R. T. Kilpatrick

served as Administrator ex officio of the estate.

After William's death, Annie (Hilliard) Willingham continued to live at Fort Meade and received \$8 a month pension for William's service in the Indian wars. While staying at the home of her daughter, Ellen (Willingham) Parker, in Bassinger, she died April 24, 1901, and was buried in the Bassinger Cemetery.

# DAVID JAMES ADDISON 1824-1886

David James Addison was born in Bladen Co., North Carolina in 1824 son of John and Ellen Addison. David grew up in Leon Co., Fla. His parents had homesteaded near Tallahassee in Leon County prior to 1827. About 1848, the Addison family moved into south Florida settling in southern Hillsborough County in the Manatee Settlement along the Manatee River in what would later become Manatee County in 1855.

On July 23, 1849, David J. Addison enlisted in Capt. Henry S. Clark's company of Fla. Volunteers as a Private. His description at the time of enlistment was given as a farmer with blue eyes, black hair & light complexion. He was discharged at Manatee on Aug. 28, 1849. He enlisted again on Sept. 19, 1849 in Capt. Clark's company in William Fisher's regiment. He served until Nov. 5, 1849 when he was mustered out at Manatee. In 1852, he applied for and received 40 acres of bounty land based on his service in Capt. Clark's companies.

On Aug. 4, 1852 David registered the following mark & brand with the Hillsborough County Clerk of the Court: crop & underbit in one ear, underbit in the other brand "52".

From January 16th until October 7th in 1856, David served as a blacksmith and farrier in his father, Lt. John Addison's company of Florida Mounted Volunteers. David Addison was a member of the jury at the Nov. 2, 1858 session of the Circuit Court held at Manatee.

David sold his stock of cattle, consisting of about 150 head, for

\$750.00 to his sister & brother-in-law, David N. & Eliza Ann (Addison)

Townsend on July 12, 1859.

In 1860 David was living in the Manatee vicinity along with David N. & Eliza Townsend, Alva Graham, William H. & Ann (Townsend) Addison, Mercer Graham, Mrs. Eleanor Rawls, Mrs. Ellen Addison & Joel and Elizabeth (Graham) Addison.

When the Civil War began, David first enlisted on April 1, 1862 at Tampa as a Private in Capt. Gettis' company of 7th Regt. of Florida Inf. This later became Company B of the 7th Florida Infantry. On June 26, 1862, he was discharged because of sickness. In 1864 he enlisted in Capt. F. A. Hendry's company of Independent Cavalry which was a division of Munnerlyn's Battalion.

On Nov. 10, 1863 at Miakka, David James Addison married Isabella Amanda Rawls. She was born in Leon County, Fla. on June 21, 1846, daughter of Cotton (Colton) & Eleanor Rawls. The Rawls family had moved to the Manatee Settlement during the 1850's from the Tallahassee area. Children of David & Amanda Addison:

- Mary Eleanor "Ellen" Missouri Addison, born Mar. 25, 1864; died Jan. 15, 1853; married in DeSoto Co. on June 10, 1888 Richard Leander Rowland.

8. John Franklin Addison, born 1887; died 1941; married Myrtle O. Derbley.

On April 30, 1866, Mrs. Amanda Addison registered with the Manatee County Clerk a mark and brand for herself and her young daughter, Mary E. M. Addison. Amanda Addison recorded: swallow fork in one ear, split in the other, brand "A2". For her daughter: crop split & upper bit in one ear, crop in the other, dewlap brand "A2".

David Addison homesteaded in the 1870's in the Platt - Fort Winder

David Addison homesteaded in the 1870's in the Platt - Fort Winder area across Peace River from Fort Ogden, where he farmed & raised cattle. David died at Fort Ogden on Mar. 3, 1886 according to two different pension applications of Mrs. Addison but a third one gave his death date as Mar. 15, 1889. No probate papers or deeds were found in DeSoto Co.

records to indicate he died in 1889.

In 1902 Mrs. Addison applied for & received a pension of \$8.00 per month from the federal government for her husband's service during the Indian Wars. She received a pension of \$120.00 per year from the State of Florida for her husband's military service in the Confederate Army. F. B. Hagan & Elias B. Keen who had served in Hendry's company during the Civil War along with David Addison gave supporting data for her pension application. Mrs. Addison died about 1912. Both were buried in the Fort Ogden cemetery. Graves are unmarked.

# DE SOTO COUNTY: CAMPGROUND CEMETERY

This cemetery is located  $11\frac{1}{2}$  miles west of Arcadia in DeSoto County on SR 70. A sign on the right side of the road reads: "Pine Level Camp Ground Cemetery one quarter mile south, cemetery maintained with contributions by loved ones, friends and members of the Pine Level Civic Club. Cemetery established before 1850". A new chain link fence was placed around the cemetery and dedicated in May 1972.

The first person buried in the cemetery was a man who was on a running horse when he was hit by a tree limb and killed. No one knew who he was. The southwest section of the cemetery is the oldest section and has very few markers on the graves, but many of the early settlers are buried there. The oldest marked grave is that of Charlotte H. Platt daughter of J. A. & M. T. Platt, born June 3, 1867, died Dec. 11, 1870.

Camp meetings were held in a bush arbor near the cemetery. Revival meetings were held once a year before a Church was established at Pine Level. A clear water branch called Pine Level Branch furnished water for the people at these camp meetings. They came from all over old Manatee County. They camped there several days during the revival, cooking their meals over campfires and sleeping in & under their wagons. Both Baptists and Methodists attended these meetings. Among the circuit riding preachers who attended & preached at these camp meetings were William Henry Messer & his wife Kezianna (Thigpen) Messer, William Penn McEwen & his wife Ruth McEwen, J. M. Hayman & his wife Martha Jane (Carlton) Hayman, John W. Hendry and W. C. Hayman & his wife Sarah (Carlton) Hayman. The Pine Level Methodist Church was established in 1868 and the Baptist Church in 1869.

The cemetery was copied by Stanley and Doris Nicholson, Rt. 3, Box 183, Arcadia, Fl. Additional information on maiden names, parents and the history of the cemetery were compiled by the Nicholsons from the following people: Annie Platt Newton, Dillie Hagan Underwood, Ora Lee Messer Layton, Floyd Mizell, Gladys Leighton, Tom Mizell & Rev. Gerald Taylor.

# 2ND REGIMENT OF FLORIDA CAVALRY

The following material is taken from National Archives published microfilm "Compiled Service Records of Volunteer Union Soldiers Who Served in Organizations From the State of Florida", Microcopy #400, Roll 7, 2nd Cavalry, A-Du.

Regimental Returns

- Oct. 1864 Entire regiment stationed at Cedar Keys except companies A & B. Co. A moved to Fort Myers by order of Col. B. R. Townsend Oct. 2. Co B moved to Fort Myers by order of Col. B. R. Townsend, Oct. 25.
- Feb. 1865 Engaged 150 men in the action with the enemy at Station 4 Florida R.R., 5 miles from Cedar Keys, on the mainland, Monday morning, Feb. 13. Although he out numbered us we drove him 2 miles. None of our men were killed. The wounded in this action were Corpl. George R. Sessions, Co. C (died Feb. 19), Pvts. Joshua H. Ellison & James Jones, Co. D and Corpl. Benjamin D. Braswell, George D. Mercer, William Stevens, Pvts. John C. Haynes, Washington Williams, Co. E. The 7 companies of the 2nd Regt. Fla. Cav. Volunteers were consolidated into five Feb. 2.
- Mar. 1865 Met the enemy and fought with 200 men at Newport Bridge, Fla. on the 6 day of March 1865 during the St. Marks Expedition. Three men on our side were killed. None of our men were wounded.

Company Returns - Company A

- April 15, 1864 This company was engaged in a skirmish on the 20 Feb. near Peas Creek destroying stores & capturing 20 horses from the enemy. Killed a notorious Rebel chief named Underhill and captured 2 Rebel spies without loss. On the 13 & 14th this company was engaged in skirmishing with guerillas near the above place and succeeded in driving them and destroying all their stores. Killed one and wounded 4 others captured 22 horses having one man slightly wounded.
- Sept. & Oct. 1864 This company during the months of July & August was on detached service in East, Middle & West Florida. Had several skirmishes with the enemy in Hernando County 7 & 8 July & again in Aug 21 had two skirmishes with enemy this day & the men of this company fought with a good will killing 4 of the enemy & wounding 8. Private A. Jackson transferred from Co. B. Besides capturing 148 bales of cotton.
- Jan. & Feb. 1865 The enemy appeared opposite the garrison at Fort Myers Feb. 20, 1865, demanded a surrender of the post & being refused a sharp artillery fire commenced which lasted about 4 hours. In meantime 20 men from A & B companies marched within 400 yards of the enemy lines when a sharp skirmishing ensued & the battle closed by the rebels retiring leaving 2 of their small arms in the field leaving bags & wallets & belts strewed along the road. Isaac T. Williams a member of Co. A being badly shocked by the explosion of a shell thrown by the enemy. The 20 skirmishers of the 2nd Fla. Cav. behaved bravely before the enemy and marched square up to the works of the rebels.
- May & June 1865 This company left Cedar Keys May 24 & embarked on board the U. S. Schooner, Matchless, and proceeded to Tampa, Fla. arriving May 27 where it has since been stationed performing detached service.
- July & Aug. 1865 This company left Tampa July 3 & proceeded on board the U. S. Steamer Gauer & McCullum to St. Marks, Fla. where it disembarked & proceeded by RR to Station #2 P&G RR where it has since been stationed.

JAMES ARTUR ALBRITTON, Co B, Private, born in Columbia Co., Fla.; 18 years old in 1865; farmer; enlisted Mar. 16, 1865 at Punta Rassa; grey eyes, light hair, fair complexion, 5°2"; mustered in Mar. 16, 1865 at Monticello.

JAMES NEWTON ALBRITTON, Co C, born in Lownds Co., Ga.; farmer; enlisted at age of 27 on April 6, 1864 at Taylor Co., Fla.; blue eyes, light brown hair; fair complexion; 5'10"; refugee from Confederacy; mustered in April 18, 1864; June 10, 1864 - appointed 3rd Sgt.; Feb. 2, 1865 - reduced to Private; July 1, 1865 - appointed musician.

JESSE JEFFERSON ALBRITTON, Co C, Private, born in Lawrence, Ga.; enlisted at age of 43 on June 10, 1864 at St. Vincent's Island, Fla.; blue eyes, brown hair, sandy complexion, 5'7"; refugee from Confederacy; died Aug. 15, 1864 at post hospital at Cedar Keys from chronic diarrhea.

JOHN MADISON ALBRITTON, Co C, born Lowndes Co., Ga.; enlisted at the age of 19 on April 6, 1864 at Taylor Co., Fla.; blue eyes, light brown hair, fair complexion, 5'8"; refugee from Confederacy.

MATHEW HENRY ALBRITTON, Co. C, Private; born Lownds Co., Ga.; enlisted at age of 38 on April 6, 1864 at Taylor Co., Fla.; grey eyes, dark hair, dark complexion, 5'7"; refugee from Confederacy; mustered out May 25, 1864; mustered in on May 26, 1864 as 1st Lt. in Co. C; assigned to Co. D. on Nov. 14, 1864.

MCPHEARSON (MCPHERSON) BARRIAN ALLEN, Co. G, born Hancock Co., Ga; farmer; enlisted at age of 37 on May 2, 1864 at Cedar Keys; blue eyes, light hair; light complexion, 5'6"; refugee from Confederacy; appointed Corpl. on May 20, 1864; transferred to Co. D as Private; promoted to Corpl. of Co. D on Feb. 2, 1865.

STEPHEN (STEVEN) W. ANDREWS (Records later show that this soldier's real name was STEPHEN W. ANDERSON. Co. E, born Craven Co., NC; Private; enlisted at age of 18 on May 19, 1864 at St. Vincent's Island, Fla.; promoted to Corpl. on May 22, 1865; gray eyes, brown hair, dark complexion; 5'5".

EDWARD JOSEPH ARNOLD, Co. C, born Lownds Co., Ga.; Private; farmer; enlisted at age of 18 years on April 6, 1864 at Taylor County, Fla.; black eyes, black hair, light complexion, 5°7"; ref. from Conf.; Appointed 2nd Corpl. on June 10, 1864; reduced to Private on Feb. 2, 1865.

HENRY GREEN ARNOLD, Co. B, born in Montgomery Co., Ga.; farmer; enlisted at 39 years old on Jan. 29, 1864 at Fort Myers; grey eyes, brown hair, ruddy complexion, 5'7"; ref. from Conf.; promoted to Corpl. Mar. 26, 1864; promoted to Quarter Master Sgt. on June 29, 1864; died Jan. 30, 1865 at Fort Myers of scurvy (also shown as chronic diarrhea).

NOTE: Spelling of words such as "Lownds" is taken directly from the wording and spelling of the service records.



In 1844 a small caravan of pioneers made their way through the wilderness of the Florida territory, leaving Alligator (Lake City) in Columbia County and finally settling in eastern Hillsborough County, about 25 miles east of Fort Brooke. This group consisted of Noel Rabun Raulerson, his brother John Baggs Raulerson, William Wiggins (who had married Emarentha Raulerson) and John Thomas (who had married a halfsister of the Raulersons).

Noel Rabun Raulerson was born in Wayne County, Georgia on July 9, 1820. His mother was Mrs. Ellen (Baggs) Brannan Raulerson, born May 6, 1785 in Georgia. It is said that his father was Nichabod (Nicebod) Raulerson (1799-1875) of Wayne & Lowndes Counties, Georgia & later Columbia County, Fla., but loss of records in Lowndes and Columbia Counties have prevented this from being proved. George G. Keen in an affidavit dated July 6, 1897 in Columbia County in support of the claim of Nichabod's widow for a pension states that Nichabod was married three times (Lucretia, Margaret Sloan & Mrs. Matilda Brill) but does not mention Ellen (Baggs) Brannan as being a wife. Nichabod mentions children from all three of his marriages in his will, dated Jan. 9, 1875 but does not mention Noel R., John B. or Emarentha Raulerson. A legal ad dated 27 Nov. 1875 found among the Nichabod Raulerson probate papers states: "To the children of Nickabod Raulerson, deceased, viz: Hardy Raulerson, Jacob Raulerson, William Raulerson, Sarah Raulerson, Caroline

Raulerson, Harris Raulerson, America Raulerson, Pellina Raulerson, Amanda L. Raulerson, Nickabod J. Raulerson, Candace Turner, Acada Barker, Pollie Raulerson, & Rebecca Waldron, Greeting." No mention of the children of Ellen (Baggs) Brannan Raulerson.

Noel moved to north Florida with his family about 1829. In the 1830 census of Alachua County (later Columbia), Eleanor Raulerson is listed as living "on the Suwannee River and little St. Mary's River" along with William Raulerson, John Becks, Fanny Raulerson, William Moore and William Hair.

Noel Rabun Raulerson served as a Private in the company commanded by Capt. Robert Brown in the Regiment commanded by Col. William J. Mills of the 2nd Regt. of East Florida Mounted Volunteers. He enrolled on June 16, 1837 and was mustered in Sept. 25, 1837 at Fort White. He was mustered out on Dec. 18, 1837 at Fort Gilliland. His written discharge was later burned. At the time of entering service his description was

given as six feet tall, dark eyes, dark hair and light complexion. He also served as a Private in the company commanded by Capt. Robert Sanderling in Col. Robert Brown's regiment during 1838. Rabun was wounded under his right shoulder in a battle with the Indians in the Okefenokee Swamp in 1838 or 1839.

In February of 1839, on the Suwannee River, Rabun married Tempie

In February of 1839, on the Suwannee River, Rabun married Tempie (Tempa) Whidden. She was born in Appling County, Georgia daughter of James W. & Mary (Altman) Whidden on Dec. 29, 1821 (according to tombstone - her father's Bible gives Dec. 19, 1821). Their children:

- 1. William H. Raulerson, born March 16, 1841; died Jan. 16, 1914; married in Polk County on Dec. 16, 1869, his first cousin, Eliza Ellender Brewer, daughter of James & Elizabeth (Whidden) Brewer.
- 2. John R. Raulerson, born June 5, 1843; died July 1864.
- 3. David Early Raulerson, born 1846; married in Polk County on April 21, 1870, Sarah Wiggins.
- 4. Mary Raulerson, born 1847; married a Mr. Raulerson, said to be the half-brother of her father.
- 5. Noel Rabun Raulerson, Jr., born 1848; died 1952; married in Polk County on March 9, 1870, Amanda Elizabeth King.
- 6. J. Archibald "Archie" Raulerson, born 1850; married in Polk County on July 10, 1872, Anne Williams.
- 7. Marentha (Emarentha) Raulerson, born 1851; married 1st, in Polk County on July 7, 1870, George W. Hayes; married 2nd, in Polk Co. on Aug. 10, 1873, Charles Hazellief.
- 8. Ellender "Ellen" Jane Raulerson, born 1854; married 1st, in Polk County on Dec. 30, 1868, George A. Lee; married 2nd, in Polk Co. on Oct. 11, 1874, Owen Turner.
- 9. Eliza Ann Raulerson, born 1855; married in Polk County on Feb. 6, 1872 Charles Thomas King.
- 10. Peter Raulerson, born Sept. 1, 1857; died Oct. 8, 1947; married in Brevard County on Oct. 17, 1877 Louisiana Chandler.
- 11. Sarah Raulerson, born May 20, 1861; died May 26, 1942; married 1st, J. Enoch Whatley; married 2nd, John Kilpatrick.
- 12. Caroline Raulerson, born 1863; died May 19, 1874.
- 13. Hardey (Hardy) Raulerson, born 1865; died 1907; married Laura Hilliard.

Noel Rabun Raulerson continued to fight the Seminoles. He was a Private in William Cone's company in Col. William J. Bailey's regiment. He served from Nov. of 1840 until March of 1841 when he was honorably discharged at Fort Macomb.

After moving to south Florida in 1844, Rabun served as a Private in Capt. S. L. Sparkman's Independent Company of Florida Volunteers. He joined on July 25, 1849 at Fort Gibson and was mustered out Oct. 23, 1849. The Raulersons & other relatives were living in the Itchepuksassa

Settlement in 1850. Rabun later established his homestead near the southeast edge of Lake Hancock, where he was shown to be residing in 1856 when the Ives military map of the peninsula of Florida was made.

In June 1852, Rabun applied for a bounty land warrent based on his previous military service. He received 160 acres in Hillsborough

County. He signed his application as "Rabon Raulerson".

"Raburn" Raulerson served as a Private from Dec. 29, 1855 to Dec. 1857 under Capt. F. M. Durrance along with his brothers-in-law James L. Whidden, John Whidden, Bennett Whidden, Lott Whidden (who was killed June 1856 near Fort Meade) and relatives, John B. Raulerson, John Raulerson, Jackson Raulerson, William Wiggins & John Thomas. Rabun's mother, Mrs. Ellen Raulerson, aged 75 years, was living with John B. Raulerson and family in 1860 census. She died June 26,

1866 and was buried in the Shiloh Cemetery near Plant City.

During the Civil War, John Raulerson, Rabun Raulerson and William H. Raulerson served in Capt. John T. Lesley's Company B, 1st

Battalion Florida Special Cavalry, Confederate Army.

John R. Raulerson was killed by lightning in July of 1864.

Caroline died May 19, 1874 from either eating too much honey or choking while eating honey. Both were buried on the Raulerson homestead near Lake Hancock.

About 1874, Noel Rabun Raulerson, Sr., moved to the Kissimmee River valley area, near Basinger where he bought land from Henry L. Parker. He was a pioneer cattleman in that area. He was listed as owning 2,515 cattle in 1862 and probably owned many more than that when he moved to the Basinger area. Noel Rabun Jr. & family settled in the Basinger area in 1876, buying land from the State for \$1.25 an acre and buying a log house from Streaty Parker. Others of the family followed & were all living in that area prior to 1880.

Rabun Raulerson moved back to Polk County prior to 1892, settling at Bartow, where he applied for and received a pension of \$8.00 a

month based on his Indian war service.

The following newspaper article appeared on Jan. 11, 1899: "Mr. Rabon Raulerson of Bartow vicinity, is in town visiting children around Bassinger. The old gentleman holds his own in vitality wonderfully well. He is now the age of 80 years, being one of the old landmarks of the pioneer settlers of South Florida. He was a soldier in the Indian, Osceola war of 1836 to 1842, and was severely wounded in one engagement with the Indians in the Indian campaign. He can tell many anecdotes about the campaign and Chief Osceola, whom he saw on several occasions. He is at present claiming a pension from Uncle Sam's crib, as a soldier of that war. He has the plural number of 100, or over, of children, grandchildren & great grandchildren, counting the living and dead."

Mrs. Tempie (Tempa) Whidden Raulerson died March 22, 1904. This appeared in a local newspaper: "Mrs. Raulerson, about 84 years of age, died at the home of her son (in-law) just north of the city, Monday afternoon, after an illness of several weeks. She died from old age, having finished her course and kept the faith to the end." Noel Rabun Raulerson died on June 16, 1910. Both were buried in the Raulerson family cemetery on their old homestead near Lake Hancock. The graves were later moved to the Gandy Cemetery near Connersville, east of

Bartow, by members of the Whatley family.
