JOHN HENRY HOLLINGSWORTH 1822-1893

This pioneer sketch was researched, compiled and contributed by a great-great-grandson of John Henry Hollingsworth, Kyle S. Van-Landingham, P. O. Box 1779, Ft. Pierce, Fla. 33450.

John Henry Hollingsworth, a son of Stephen and Elizabeth (Colwell) Hollingsworth, was born in Sampson County, North Carolina April 18, 1822. His age as recorded on various documents varies, so he may have been born as late as 1825.

As a boy he went with his parents to Tallapoosa County, Alabama, during the mid 1830's. From there they went to Columbus, Georgia where his mother died; then Thomas County, where his father remarried in 1838. Shortly thereafter, the family moved to Jefferson County, Florida where they are shown on the 1840 census. During the Second Seminole War, John Henry served in Capt. Lewis Martin's company for a period of twelve months.

After passage of the Armed Occupation Act in 1842, which opened up south Florida for settlement, the Hollingsworths moved to Hillsborough County. On July 24, 1845, John Henry Hollingsworth was married to Ann Elizabeth Hooker, daughter of William B. and Mary Amanda (Hair) Hooker. Ann was born in Hamilton County, Florida, Sept. 5, 1831 and moved with her parents to Hillsborough County in 1843.

After their marriage, John Henry and Ann moved to the Manatee settlement, located in southern Hillsborough County, where they appear on the 1850 census. However, in the early 1850's they moved to what is now Polk County, settling on the south shore of the lake that now bears John Henry's name, Lake Hollingsworth at Lakeland. According to family tradition, they soon left because strong winds across the lake kept slamming their doors. John Henry had previously filed for a land grant at Newnansville, his claim listed as being "near Fort Sullivan".

When the Third Seminole War broke out, John Henry Hollingsworth enlisted in the volunteer militia company commanded by his fatherin-law, Captain William B. Hooker. The company was mustered into state service, Jan. 3, 1856; later into federal service, Feb. 27, 1856. On June 14, 1856, an Indian raiding party attacked the homestead of Willoughby Tillis near Ft. Meade. John Henry was one of seven men who rode from the fort to the Tillis place to relieve the family. During the battle which followed, he was seriously wounded. Capt. Hooker's report stated: "Hollingsworth's wound is worst, the ball lodging against the backbone under the shoulder blade, --but it looks as though he will recover."

John Henry did recover, but he was to remain partially disabled for the rest of his life. On August 21, 1857, he applied for a pension from the U. S. government. He stated that the rifle ball could not be extracted from the backbone and rendered him unable to perform bodily labor. Supporting affidavits were filed by Capt.

Hooker, Henry A. Crane, Henry L. Parker and two surgeons. The surgeons stated: "The injury has so affected his nervous system, that he is incapable of performing his accustomed labor. He cannot stoop down and rise without pain. He is unable to raise any considerable weight, without producing pain in the spine. A lateral motion of the body also produces pain."

After his injury, John Henry and his family resided at Tampa where he operated a boarding house. After 1858, they moved again, this time to Manatee County, where they appear on the 1860 census.

The children of John Henry and Ann Elizabeth (Hooker) Hollingsworth were:

- 1. Martha Jane Hollingsworth, born February 12, 1847; married William Alderman on March 16, 1863. She died on December 25, 1929. (See Issue #4 of SOUTH FLORIDA PIONEERS for biography of William Alderman).
- 2. Robert R. Hollingsworth, born 1849; died single before 1870.
- 3. William H. Hollingsworth, born 1851; married Delilah Waldron on December 25, 1873.
- 4. Mary A. Hollingsworth, born 1854; died single before 1870.
- 5. Julia Fredonia Hollingsworth, born 1859; married Joseph Brewer.
- 6. Lillie Hollingsworth, born 1865; married William Stewart.
- 7. James Jasper Hollingsworth, born 1867; never married.
- 8. Florida Apolonia (Abbie) Hollingsworth, born Feb. 14, 1872; married Edward Lanier on December 21, 1899.

Upon their removal to Manatee County, John Henry engaged in farming and cattle raising. The Civil War began in 1861 and he was unable to claim his pension for a number of years. On Feb. 9, 1863, the Manatee County Commission made provision for care of families whose husbands were away at war. A committee was appointed to gather supplies and John Henry was chosen to haul and distribute the corn and various other supplies to the families.

Manatee County's oldest Mark and Brands Record Book shows that on October 10, 1863, John Henry Hollingsworth registered the brand for use on his cattle. The same day his son William H. Hollingsworth registered the brand for her cattle. Marth's husband, William Alderman, had registered the brands W and 85 on Mar. 16, 1863.

John Henry Hollingsworth and his family appear on the 1870 census for Manatee County, residing in Township 39, the site of Fort Ogden. According to the census, next door neighbors were brother-in-law, Zorra J. Curry; son-in-law, William Alderman; and half-brother, Sim Hollingsworth.

In 1877, John Henry Hollingsworth once again applied for the invalid pension he had originally sought twenty years earlier. An accompanying affidavit describes him as having blue eyes; being five feet, eleven and three-quarters inches in height; hair nearly gray; weight, about 150 pounds; medium-stout build; with light complexion. The affidavit is dated April 8, 1878, and says that "the rebellion prevented my ever receiving pension, as my agent said that it was allowed." The application was approved and he received \$8 a month until his death.

John Henry Hollingsworth continued to live in Manatee County about ten miles north of Fort Ogden, his family being

shown there on the 1880 census. During the early 1880's, he moved to Monroe Co., settling on the Caloosahatchee River at Fort Denaud. There John Henry operated a ferry, providing trans-

portation across the river. In the 1885 census, he is shown as "ferryman", residing with his wife and three youngest children in Monroe County. Also in the household was the oldest daughter, Martha Jane Alderman, and her four youngest children by William Alderman.


A few years later, John Henry and his family returned to the newly formed DeSoto County, and made their home at Arcadia. Here, on August 15, 1888, Ann (Hooker) Hollingsworth died. She was buried at Joshua Creek Cemetery.

During his remaining years, John Henry travelled around a great deal, visiting his brothers, sisters and children. In the early 1890's he was staying with his daughter, Martha Jane Alderman. He developed a cancer on the side of his face and his health gradually declined. His oldest surviving son, William Hollingsworth, came down to Arcadia in a covered wagon and took his father back to his home. There, in late 1893, John Henry Hollingsworth died. His body was brought back to Arcadia where he was buried at Joshua Creek Cemetery.

WILLIAM ALDERMAN 1838-1893: ADDITIONAL INFORMATION

Kyle S. VanLandingham has prepared some additional information on William Alderman whose sketch appeared in Issue #4. He has also contributed the photo of Mr. Alderman who was a son-in-law of John Henry Hollingsworth whose sketch appears in this issue.

During the early years of the Civil War. William Alderman, though refusing to join the regular Confederate Army, did become a member of the Cattle Guard Battalion under Capt. John T. Lesley. group, known as Company B, 1st Battalion, Fla. Special Cavalry, C.S.A., was organized in 1863. As the war dragged on, William Alderman along with many others, turned completely to the Union side. Some joined the Union 2nd Fla. Cavalry at Ft. Myers. William offered to join but was told he would be more helpful in supplying beef cattle to the Union garrison. He also hunted deer on Pine Island, near Ft. Myers, supplying the needs of the Union garrison.

After moving from Fort Ogden to Pine Level in the mid-1870's, William operated a 10 room hotel and owned citrus groves. He also continued his extensive cattle operations.

NEW ZION BAPTIST CHURCH CEMETERY

The New Zion Baptist Church was organized Sept. 29, 1866 at a point on the South Fork of the Alafia River but is now located about seven miles west of Ona in Hardee County, Florida. It was first known as the Maple Branch Baptist Church. Elders J. M. Hayman, A. Wilson and S. L. Cross met with the regular members of the Baptist Church residing in the Maple Branch vicinity for the purpose or organizing a Church. S. L. Cross was chosen to be pastor and J. W. Whidden to be Church clerk. J. W. Hendry was pastor in 1868 and Timothy Bryant was delegate to the South Florida Baptist Association representing the thirty-two members of his Church. 1870 delegates were J. W.

Hendry and M. Alderman. By 1872, membership had climbed to 49 and Seth Howard was delegate to the Association. In 1873, the Church was moved to the New Zion community and its name was changed from Maple Branch to New Zion Baptist Church. Delegates that year were J. W. Hendry and R. Roberts. N. T. Jones and William McLeod represented their 81 members in 1874. Other early members were Albert Carlton, Louis Carlton, Wright Carlton, Alderman Carlton, J. M. Hendry, James Albritton, William Whidden, Daniel Garner, Matthew Alderman, Robert Roberts, W. Coker, R. Marlow, E. J. Hull, I. A. Redd, W. F. Norris, D. W. Hull, Z. F. McEwen, H. H. Norris, W. Rich, J. Strickland, J. F. Chancey, J. B. Stephens, Franklin Shuman, J. L. Durrance, W. D. Payne, J. H. Hayman and John Coker. To reach the cemetery, turn west on SR 64 off of US 17 and travel west 14.0 miles. Turn north on Sidney Roberts Road and travel 0.2 miles and the cemetery and Church are on the right side. went southward to Trabue, the coming city of the South.

HARRIS KEEN 1833-1858

Harris Keen was born in 1833 in Columbia County, Florida, son of David Keen and Elizabeth Fitzgerald. His parents had married in Tattnall County on 18th of Jan. 1822. He was probably a half-brother to James M. Keen (see Issue #2 of SOUTH FLORIDA PIONEERS). Although Harris Keen was never an actual pioneer of South Florida, his only son and relatives of his wife settled in Polk County in the early 1870's.

Harris served as a musician in the Company of Florida Volunteers commanded by Capt. Joseph J. Knight in the 1849 Seminole Indian disturbances. The company was called out by Florida Governor Mosely. Harris volunteered at Alligator in Columbia County on 7th of August and was discharged at Alligator on 27th of October 1849. He received a Bounty Land Warrent of 40 acres for this military service.

On the 30th of April 1852, Harris Keen married Rozetta (Rosetta) Walker, daughter of Ansel & Sarah Walker. Rosetta's first cousin, Nancy Walker, daughter of Jeremiah Walker & Nancy Dowling, married David Keen, son of James M. Keen. Harris & Rosetta Keen had one child:

1. Silas Owen Keen (Keene), born September 4, 1854 in Columbia County, Florida; died Jan. 26, 1940, buried at New Zion Cemetery in Hardee County; married Mary Serena Byrd in Polk County on Nov. 27, 1873. She was born Mar. 29, 1856 and died Aug. 24, 1935.

In 1857, Harris Keen once again volunteered for service in the Florida Mounted Volunteer Company commanded by Capt. Henry Harrington. He enlisted as a Private at Alligator on July 23rd. It was while he was in this service that he died on January 12, 1858. His wife had died earlier on December 17, 1857. Rosetta's father, Ansel Walker was appointed guardian of Silas Owen Keen on Nov. 14, 1859. Silas lived with the Walkers in Columbia & Levy Counties and with his Grandmother Keen until the early 1870's when he moved to Polk County

with his Grandfather Walker and uncle, Isham Walker, who was listed as guardian of Silas O. Keen in the annual settlement of the estate of Harris Keen for the year 1873 in the Polk County records. Silas received a pension from the government based on the military service of his father.

James Washington Mathis was born in 1834 in Lowndes County, Ga., youngest son of James Mathis (1786-1859) and Rhoda Monk (1792-1863). James Mathis, born 1786, was a son of Edmund Mathis, Jr. and grandson of Edmund Mathis, Sr., Revolutionary Soldier of Duplin (now Sampson) County, North Carolina. Rhoda Monk Mathis was the daughter of William Monk (1763-1825) and Jerushia Parrish (1773-1857).

There seems to have been a mix-up on the spelling of the surname "Mathis" for the last several hundred years. Records have been found where a person spelling his name "Mathis" at one time spells it as "Matthews" another time. It is also spelled "Matthis". When James and Rhoda Monk Mathis were married in Bulloch Co., Georgia, the county records show the name as "Matthews" but census & other info give it as "Mathis". When James W. Mathis' first wife remarried, the name "Mathis" was used but later when their daughter married, the name "Matthews" was given on the marriage record. According to family tradition, the correct usage is "Matthews" but most of the children of James W. Mathis use "Mathis".

James W. Mathis married Mary Ann Williams in Columbia County, Florida about 1856. She was born in 1842 in Columbia County, daughter of Rowland Williams (1812-1867) and Nancy Ann "Annie" Sweat (1816-1908). (See sketch on Rowland Williams in Issue #1). James & Mary Ann Mathis had two children:

- 1. Emily Augusta "Gussie" Mathis (Matthews), born May 25, 1857; married in Manatee County on January 13, 1873, Eley P. Brannan, son of David Brannan and Susan Whidden, grandson of Maxfield Whidden and Sophia Crews.
- 2. Margaret B. Mathis, born April 15, 1859; married 1st, John Brooker, about 1875. He was born 1856. She married 2nd, Miller.

The Mathis family moved to south Florida in the late 1850's along with the Rowland Williams family, settling in Manatee County in the vicinity of Brownville. James returned to Columbia County apparently because of family problems for Mary Ann Mathews & the two girls are shown in the 1860 Manatee County census living with Henry and Jane Whidden Langford. Mary Ann filed for divorce and the following legal ad appeared in the June 30, 1860 issue of the Florida Peninsular of Tampa:

Bill of Divorce

Circuit Court, State of Fla, Southern Circuit
Manatee County

Mary Ann Mathews

Bill in Chancery For Divorce

James Mathews

It appearing that the bill in the above entitled cause, has been filed and by the affidavit that the said James Mathews resides out of said circuit, to wit, in the County of Columbia, in said state, it is ordered that the said James Mathews do appear and plead, answer or demur to said bill.

June 2, 1860

No other information concerning the divorce could be found but apparently it was finalized for on July 14, 1860 in Hillsborough County, Mary Ann married Edward Whidden.

James W. Matthis joined the Georgia Confederate Army on Aug. 1, 1861 at Savannah. He enlisted as a Private in Capt. Levi J. Knight's Company C (Berrien Minute Men). This company was later designated as Capt. Thos. S. Wylly's Company and also as Company G, 29th Reg't of Georgia Infantry. Regimental return for August 1862 gives the rank of J. W. Matthis as Corporal and that he was absent - sick in hospital or convalescent camp. His name appeared on a clothing receipt roll at Buckner & Gamble Hospital at Fort Valley, Georgia in Nov. 1864. J. W. Mathews appeared on the list of prisoners of war surrendered to Brig. Gen. E. M. McCook by Maj. Gen. Sam Jones, C.S.A., at Tallahassee on May 10, 1865. His description at this time was given as follows: 6 feet 2 inches tall, black hair and grey eyes.

James returned to south Florida after the Civil War. On April 10. 1867, he married Sarah "Sally" Jane Williams, younger sister of his first wife, Mary Ann Williams. Sally was born February 9, 1852 in

Columbia County, Florida. Their children:

- Henrietta "Etta" Elizabeth Matthews, born Feb. 9, 1868; died Dec. 30, 1959; married in DeSoto County on July 31, 1890 John Sloan, son of Alford Sloan & Celia Whidden.
- Rhoda Louannie Mathis, born 1868; married Daniel Coker in DeSoto County on Oct. 16, 1889.
- George Riley Mathis, born 1871; married Catherine Hagen. 3.
- Martha Jane Mathis, born Nov. 6, 1873; died Sept. 14, 1943; married 1st, Carl W. Walker; married 2nd, John Dailey.
- 5. Edna Josephine Mathis, born 1874; married Portus Drawdy on Jan. 3, 1896.
- 6. James Westberry Mathis, born 1876; married Elizabeth Daniels.
- 7. John Mahlon Mathis, born Feb. 10, 1877; married Ida Smith on Feb. 27, 1901.
- 8, Henry Washington Mathis, born Jan. 26, 1878; died June 18, 1953; married Bertie Andrews.
- 9. Blanche Mathis, born 1879; died before 1885.
- 10. Willie Agnes Mathis, born Jan. 31, 1881; married William Hearn in 1899.
- 11. Laura Belle Mathis, born Nov. 21, 1886; died Feb. 26, 1965; married William Lacey DeVane in 1901.
- 12. Walter Mathis, born 1887, died young.
- 13. Joseph Reuben Mathis, born 1888; died June 8, 1957; married Bessie Worley Thorne.

14. Eugene Lafayette, died single on July 7, 1929.

James Washington Mathis was a farmer and a cabinet maker. His customers would pay him in potatoes and skins of animals. The Indians would give him buckskins in trade. He was also a born orator and was paid to make speeches for less gifted men running for office. To make extra money he would make shingles out of cypress trees. This would necessitate hunting for the right kind of tree which usually grew in a swamp. When he found one he would take his wife and children with him, as it would take several months to complete the job. Instead of living in the covered wagon, James would build a palmetto shanty, with only one opening which served as the door.

One night he wanted to go hunting, so he built a fire not too far from the door to discourage animals from snooping around. It did not work, however, as a bear came lumbering along. Of course, the dogs did not like his intrusion, so the battle began. In their fight, the fire was extinguished. The bear was winning and the dogs were pushed back into the open door. His wife had the gun ready but the bear decided it was not worth the fight and left. The oldest daughter, Etta, had to rebuild the fire while her mother watched with gun ready in the

event the bear decided to return.

For the children's pleasure, James built a boat which they named "Dido". One night James thought he heard a woman screaming across the river. He boarded the boat and rowed across but just before he set foot on the other side, he realized it was a panther instead of a woman.

One other night Mr. Mathis was hunting on horse back when some kind of animal sprang on the back of the horse, just behind him. The horse in his panic dislodged the animal. Needless to say the horse and rider

never stopped until the reached home and safety.

James had a fairly good education for those pioneer days. He had attended an academy in Augusta, Georgia when a young man. He learned to make violins and made one for himself. After coming to Florida, he also served as a dentist for the pioneers, and treated the Indians when

they were sick.

When James' son, George Riley Mathis was about ten years old he fell out of a window and a rough piece of rock gut a gash in his stomach several inches long. His insides were protruding. James washed them and put them back into the stomach and sewed up the opening with a needle and thread. He went to a pine tree which had been gashed and took some of the sap from the cut area. James made a plaster of it and used it to cover the wound. It stayed on the wound until it dried up and flaked off. All this was done without the help of anesthetic, not even an aspirin. George recovered and lived to be an old man.

James W. Mathis died from pneumonia while on a hunting trip in north Florida on October 15, 1893. He was buried at Center Hill, Florida. Sally later married Washington Morgan. She died in Tampa on Feb. 1, 1946 and was buried in the Fort Ogden Cemetery in DeSoto County.



DE SOTO COUNTY: ARCADIA'S FIRST COURTHOUSE

Due to complaints and disturbances in the eastern sections of Manatee County, Florida, the State Legislature decided that the division of the county into two separate counties would be the most appropriate action. Thus, in 1887, De Soto County was created. The old county seat of Manatee County, Pine Level, was to remain as the county seat of the new county. De Soto County stretched from Lake

Okeechobee, Fort Basinger and the Kissimmee River on the east; two miles beyond Bowling Green to the north; Pine Level and Castalia on the west; Grove City and Placida to the southwest; and the Caloosahatchee River & Gilchrist to the south.

The <u>County Commissioners</u> <u>Record Book #1</u> shows that the minutes of the August 1887 meeting of the County Commissioners listed the

following voting precincts for the county:

Fort Green Hartsuff Coker Pine Level Charlotte Harbor

Fish-Eating Creek Fort Basinger Grove City Trabue

Fort Ogden Arcadia Locklar Popash

In the months that followed the creation of De Soto County, people began wondering if perhaps the new county should have a new county seat. There were quite a few booming little towns which would love to receive the honor. On July 7, 1888, J. W. Whidden, L. Parker, J. N. Parker and W. E. Daniels gave bond to the County Commissioners for the completion of a Courthouse at Arcadia, according to plans to cost not less than \$3,000.00 provided Arcadia be elected as the permanent county seat. Chris Pierce offered 80 acres of land provided Brownville be elected. Albert W. Gilchrist offered \$1,000.00 provided that Nocatee be elected. Zolfo also extended an offer.

In the election held in August 1888, no place in the county re-

ceived a majority of votes. The balloting showed:

Arcadia, 295 votes Fort Ogden, 186 votes Nocatee, 110 votes Pine Level, 59 votes

Fort Bassinger, 1 vote Bowling Green, 1 vote Punta Gorda, 2 votes Zolfo, 1 vote

Several more elections were held before one community finally received a majority of votes. In the October 1888 election, Arcadia received 448 votes out of a total 875 votes cast, thus becoming the new county seat. The number of votes the other towns received were not recorded in the Commissioner's records.

In November 1888, the Commissioners ordered that the Clerk of the Circuit Court and County Judge and Supervisor of Registration, remove the records and furniture of their respective offices from the old courthouse at Pine Level to a temporary building to be used as the courthouse in Arcadia until a new building could be built. Mr. C. C. Pearce who bid \$22.00 was given the contract to transport the courthouse records & contents. He undertook this move by ox cart, but being unable to cross Peace River with his team, sublethis contract to Little Bryan who conveyed the materials to Arcadia.

The County Commissioners appropriated \$3,000.00 to go along with the \$3,000.00 donated previously. The contract was awarded to Peyton R. Read. "This agreement made and entered into this 12th day of Dec. A.D. 1888 by and between Peyton R. Read Contractor, party of the first part and Marion G. Carlton, B. F. Richards, Peter Brown, S. T. Langford, T. O. Parker, W. E. Daniels, J. A. Parker, L. H. Parker and J. W. Whidden composing a building committee, party of the second part, all of the County of De Soto and State of Florida."

The finished courthouse is shown in the picture at the first of this article. It was located in the same area as the present day courthouse. The photograph was contributed by Mrs. Grace P. McClenithan, R. #2, Box 318M, Sarasota, Florida 33577. The specifications of the first courthouse in Arcadia were as follows: To be a brick pillows foundation 18" wide 48' long at base and tapering to

18" at top. Said pillows are to be 6' apart at top of pillow through out the building. Sills are to be 8×10 . Lower joing to be 2×10 , 2' apart. Middle to be 2×10 , 2' apart. Upper to be 2×2 , 2' apart. Studding for corners 6 x 6. Studding to be 2 x 6, 2' apart. Studding at openings outside 4 x 6. Rafters 2 x 6, 2' apart. Rafter to have 3 rows to ties. Rafter to have wind beams. Plates to be 2 x 6 double. Sheating to be 1 x 303 in. apart. Shingles to be of first class Cypress. Flooring to be 1 x 4 matches. Novelty siding. Novelty ceiling 1 x 4. upper rooms. Beaded ceiling, lower rooms. All valleys to be 14 inc. tim. Corners to extend 3' with moulding. All outside doors to be doubled on first floor. All other doors to be 21 x 6/10 12 panel doors. All windows according to plan which is to be downstairs 3 x 7' opening up stairs 3 x 10'. Opening crestling and gables according to plan. Court room seated with raised seats on aisle in center on aisle on each side. Aisle to be 7 wide. Judges stand and jury box to be raised with fence railing. Position of all rooms to be according to plans. Stairway to be 4' wide. All materials to be of first class stock. All work to be done in workman like manner. Coats of paint to be of oil and lead. Windows to be with weights and cords. The land 4 acres to be cleared of timbers. Above specifications signed by each member of the building committee. On June 5, 1889, the committee accepted the courthouse.
